#### 93Q "ELF ON A WEBPAGE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNTQ-FM ("Station"), 1064 James St., Syracuse NY 13203, during available business hours Monday through Friday, on the Station website www.93Q.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **93Q "Elf On A Webpage"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

# 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
